DIRECTIONS FOR USE

Restraints: DO NOT place pellets in heaps.

CROP/SITUATION	PEST	RATE	CRITICAL COMMENTS
Seedlings and mature crops of vegetable and flowers, potted plants and all areas where snails and slugs congregate	Snails, Slugs	5 grams per 1 square meter.	Scatter pellets after rain, or water area to be treated prior to application. Keep away from dogs. Dogs find this bait attractive and it may kill them. If pets or livestock are poisoned contact a Veterinary Surgeon.

WITHOLDING PERIOD

DO NOT harvest edible plants for 7 days after application.
